RAFFLE TICKETS

PROCURE is issuing a maximum of 10,000 raffle tickets, numbered from 00001 to 10000, for a chance to win a trip for two to the 2027 Super Bowl—February 11–15, 2027 — Los Angeles, California — with a total value of \$47,275.00 (including provincial and federal taxes).

Lottery tickets, priced at \$50 each, will be available for purchase from July 15, 2026 through January 28, 2027, at 12:00 p.m. (EST), through a purchase form on the PROCURE organization's Shopify online store (boutique.procure.ca).

An individual may purchase as many tickets as they wish, up to the total number of tickets available for the drawing.

Participation in the drawing is limited to individuals who reside in Québec and are 18 years of age or older. Employees of PROCURE, members of its board of directors, employees of Roadtrips, and employees of any other partners associated with the lottery, as well as individuals residing at the same address, are not eligible to participate in the lottery.

No ticket purchase may be canceled or refunded, and no ticket purchase entitles the purchaser to an official tax-deductible donation receipt.

PAYMENT METHOD

Payment for the raffle ticket, priced at \$50, must be made in full by credit card through PROCURE's Shopify online store (boutique.procure.ca).

PRIZE DRAW

The winner will be contacted by phone or email by PROCURE within 2 business days following the drawing.

By entering the lottery, participants consent to the publication of the winner's name.

PRIZE CLAIM

The reservation and travel arrangements must be made through a representative of PROCURE, who will coordinate the booking process with Roadtrips.

PRIZE TERMS AND CONDITIONS

- The winner may transfer the Prize, as described in these rules, to another person of their choice who is 18 years of age or older.
- If the winner refuses the Prize, it cannot be converted to cash and will be considered void. If any portion of the Prize is not used, in whole or in part, no monetary compensation will be provided.
- The winner must make the reservation and all travel arrangements directly with Roadtrips, exclusively and without exception.
