RAFFLE TICKETS

PROCURE issues a maximum of 10,000 raffle tickets, numbered from 00001 to 10000, to enter the raffle for a chance to win a golf trip for four to Los Cabos, Mexico, from November 12 to 19, 2026, valued at \$20,780 (including provincial and federal taxes).

Tickets, costing \$100 each, will be available for purchase from April 27 to September 28, 2026, at 12:00 p.m. (EST) via a purchase form on PROCURE's Shopify online store (boutique.procure.ca).

An unlimited number of tickets may be purchased by a single person, up to the total number of tickets available for the raffle.

Participation in the raffle is limited to individuals residing in Quebec who are 18 years of age or older. Employees of PROCURE, members of its board of directors, employees of Voyages Gendron, Gendrongolf, and other partners affiliated with the raffle, as well as individuals residing at the same address, are not eligible to participate in the raffle.

No ticket purchase may be cancelled or refunded. No official donation receipt for tax purposes will be issued for the purchase of a raffle ticket.

PAYMENT METHOD

Payment for the \$100 raffle ticket must be made in full by credit card through PROCURE's Shopify online store (boutique.procure.ca).

PRIZE DESCRIPTION

Prize: A trip for four (4) persons to Los Cabos (Mexico)

Travel dates: November 12 to 19, 2026

Total Prize value: CAD \$20,780.00

The Prize includes:

- Round-trip flight from Montreal to Los Cabos with WestJet;
- Seven (7) nights all-inclusive accommodation at the 4-star Riu Santa Fe in a standard double room;
- Five (5) rounds of golf with a cart at the following courses: Club Campestre San Jose (1x), Puerto Los Cabos Golf Club (1x), Cabo Del Sol (1x), Solmar Golf Links (2x);
- Food and drinks included on the course at Puerto Los Cabos Golf Club and Solmar Golf Links;
- Round-trip transfers between the golf courses and the hotel;
- Advance booking of tee times
- Welcome meeting;
- Luggage fees for one checked suitcase;
- Carry-on baggage fees;
- Services of Richard Gagnon and Sylvie Godbout, Gendrongolf group leaders;
- Airport transfers;
- Protection provided by the Compensation Fund for Customers of Travel Agents;
- Federal and provincial taxes.

The Prize does not include:

- Gratuities;

PRIZE DRAW

The draw will take place on Thursday, October 1, 2026, at 12:00 p.m. (EST) at the PROCURE office (PROCURE, 1320, boul. Graham., Mont-Royal, Quebec, H3P 3C8) in the presence of at least three witnesses.

The winner will be contacted by phone or email by PROCURE within two business days of the draw.

Entry in the draw implies consent to the publication of the winner's name.

PRIZE CLAIM

The winner will be put in contact with a Voyage Gendron representative to claim their prize. The winner must make all travel bookings and arrangements directly with Voyage Gendron. The winner and their guests must consent to receive communications from Voyage Gendron.

PRIZE CONDITIONS
